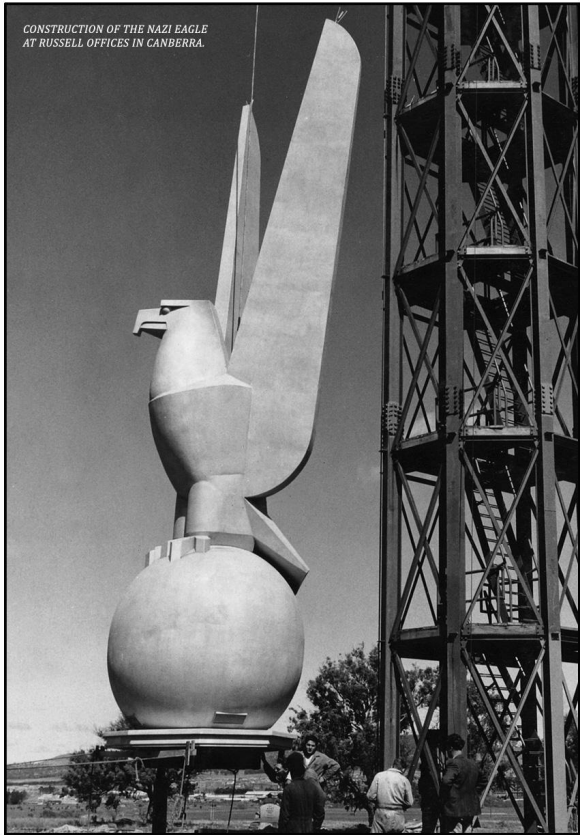

THE BLACK BOOK is intended as a master reference and companion guide and is book three in the series by Thomas Anderson.

This book obviously only represents a small portion of the information available on the Illuminati and the global elite, and so I have tried to include things that are relevant to Australia and that are not common knowledge or found in other researchers work.

The main idea is to provide you with a visual reference guide and overview in an easy to read manual so that you may conduct your own investigations by using this information as a starting point.

Some of you may already know much about the topics covered, whereas others who are new to this research may be completely unfamiliar with the names and images, so please keep that in mind, as it is my aim is to provide something for everyone to work with.

There has been a great deal written over the years about the Illuminati, Tri-Lateral Commission, Bilderbergs, Council on Foreign Relations, UN, Freemasons, City of London, Vatican, Rothschild, Rockefeller, Warburg, Bohemian Club, Jesuits, Zionists and so on by researchers such as Stephen Knight, Michael Baigent, Richard Leigh, Jan Van Helsing, William Cooper and many others.

THE GLOBAL ELITE

I have been independently conducting my own research now since 1991, and have consumed massive amounts of information in the quest to discover the truth, which some still think is just a conspiracy theory. I wish that were true.

The greatest problem facing all researchers is that the global elite does not openly advertise who they are, so we are left following a trail of breadcrumbs where they have previously been.

Fortunately as more people dig deeper into their affairs, we are beginning to see a picture forming of what is really going on behind the scenes.



The infamous U.S one dollar bill has become the most recognized icon that people refer to when discussing the NWO.

It's Masonic and Occult symbolism is well documented in such places as Ripley's Believe it or Not Museum on the Gold Coast. The inscription ANNUIT COEPTUS means "God has favoured our undertakings".

NOVUS ORDO SECLORUM of course means "New Order of the Ages" – generally taken to mean New World Order. The background design is a spider's web with a tiny hidden Owl, and the prominent All-Seeing Eye of the "Illuminated Ones" sits atop the all too familiar Egyptian Pyramid.

The Pyramid has 13 steps and there are 13 stars making up the Star of David, 13 arrows, 13 olive leaves, 13 stripes on the shield and 13 letters in each of ANNUIT COEPTUS and E PLURIBUS UNUM. The inscription on the sash held in the beak of the Phoenix translates as "out of many...one".

There are many theories behind the meaning of the number 13, the most common being the 13 States of the Independence and Jesus with his 12 disciples making 13. The personification of astrological deities would translate as the Sun with the 12 houses of the Zodiac.

Interestingly, important dates such as Christmas coincide with major equinoxes and solstices and seem to represent celebrations rather than actual birthdays.

Whatever the true meaning, 13 is one of the most important numbers in Masonic and Occult history, the 13th card of the Tarot being "Death", or re-birth.

As we are about to enter an unprecedented era in history, where the global elite are manufacturing a world economic crisis that is being labeled "The Greatest Depression", I thought it appropriate and timely to release this book now, instead of later so as to assist with the awakening of consciousness on this planet to what is going on behind our backs.

As I mentioned in book one, CLASSIFIED – those of you who have lost homes because of Banks stealing your property, please consider the following.

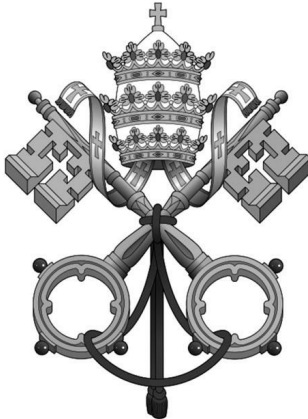

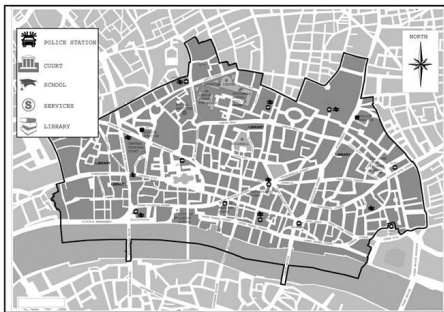
In this book, I will try and present an overview of the most relevant information and try to link all the pieces together. I personally like to dig deep to discover the background of things, who's involved and where things come from.

CITY OF LONDON

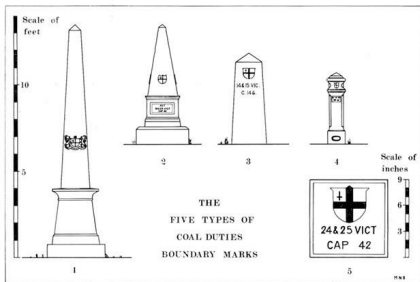
"Welcome to the City of London Corporation" is the heading that greets you at their official website www.cityoflondon.gov.uk and if you can locate the link to "franchises" it will take you to a new webpage describing voting rights for the EU (European Union). It could be therefore taken that the EU is merely a "Franchise" of the City of London Corporation.

The City of London provides local government services for the financial and commercial heart of Britain, the 'Square Mile'. The City of London combines its ancient traditions and ceremonial functions with the role of a modern and efficient local authority, looking after the needs of its residents, businesses and over 320,000 people who come to work in the City every day. Among local authorities the City of London is unique; not only is it the oldest in the country but it operates on a non-party political basis through its Lord Mayor, Aldermen and members of the Court of Common Council.

It runs its own police force and the nation's Central Criminal Court, the Old Bailey.

It provides five Thames bridges, runs the quarantine station at Heathrow Airport and is the Port Authority for the whole of the Thames tidal estuary. Three premier wholesale food markets (Billingsgate, Spitalfields and Smithfield) which supply London and the South East with fresh produce also belong to the City of London. It's described as "a unique authority".

TRADE BOUNDARIES



These are the phallic Egyptian Obelisk-styled Boundary Markers that border the City of London Corporation and were originally referred to as Coal Duty Boundary Markers as they governed the passage of trade in and out of the City.



The largest and most famous Obelisk is situated on the banks of the River Thames, known as Cleopatra's Needle.

The City of London Coal Duties

and their boundary marks

WHEN the Corporation of London took stock of its affairs after the Great Fire of 1666, it found itself in debt to the extent of about £240,000. It accordingly appealed to Parliament for help, with the result that it was authorised to collect duties on all coals brought into the Port of London and certain areas around London. By the First Rebuilding Act of 1667, (19 Charles II, Cap. 3) Parliament authorised a duty of one shilling per chaldron, a measure of about 25 hundredweight, for ten years on all coals brought into the Port of London between Yantlet Creek in Kent and Staines in Middlesex. The duties were to be used for widening and rebuilding streets, rebuilding wharves, prisons, etc. Section 29 enacted that a column was to be erected as a "Remembrance" of the Fire, our present-day "Monument."

The duties yielded about £10,000 a year, which was not nearly enough for the City's needs. A Second Rebuilding Act of 1670 (22 Charles II, Cap. 11) increased the duties to three shillings and extended the period. This Act provided funds for rebuilding Saint Paul's Cathedral and 51 of the 86 churches destroyed in the Fire, as well as for some City properties, including Guildhall, the City's markets and Newgate Prison. Only the actual church buildings were paid for out of the duties; the internal fittings being provided by the vestries and private benefactors. It took eight years to demolish Old Saint Paul's, while the rebuilding lasted from 1675 to 1710 and cost about £747,000. The Cathedral authorities and private donors spent about £100,000 on the internal fittings and decorations. The cost of rebuilding the 51 churches was about £265,000, the most expensive being Saint Mary-le-Bow, at £15,421.

The "Stop of the Exchequer" by Charles II on 2 January 1672 brought more financial trouble to the City and bankruptcy to many leading bankers, from whom the King had borrowed about

£1,300,000. This amount included trust funds held by the Corporation of London on behalf of the orphans of City Freemen. To help the Corporation to meet its debts Parliament passed an Act for the Relief of the Orphans and other Creditors of the City of London (5 and 6 William and Mary, Cap. 10) in 1694, authorising a duty of 4s. per tun on wines brought into the Port of London and certain extra metage fees and duties on coals. Further Acts of Parliament enabled the City to be free from debt by 1834. From 1767 onwards the duties were used for making many improvements in and around London, including building Blackfriars Bridge, making road improvements at Temple Bar and Snow Hill, including Holborn Viaduct, and building the new Coal Exchange, which was opened in 1849 and demolished in 1963 for road-widening.

Dear Mr Anderson,

I write in response to your email to the Contact Centre, which has been passed to me.

As far as I am aware the City of London Corporation has no role in the governance of, or special interest in, the Commonwealth of Australia, which is to my understanding the 'proper name' for the nation of Australia. Similarly the Lord Mayor and the City Corporation's other elected Members, and its Officers have no official role with regard to Australia. I am sure, however, that some of them may well have private family or business interest there as indeed they may do with respect to any other country. .

You state that that your query arises from concerns over your 'status' following emigration from the United Kingdom to Australia. I would suggest that you should take up those concerns with the Australian Department for Immigration and Citizenship and/or the British High Commission in Canberra who would be much better placed to give you a definitive answer.

You also enquire about a company registered as Crown Land Worldwide Limited. As far as I am aware the City of London Corporation has no links with this organisation and I would suggest that you take up any issues directly with them.

Finally you enquire about the term 'Freeman'. In the context of the City of London Corporation's website this refers to a person who has obtained the Freedom of the City of London. It is not a reference to 'an English Freeborn Man'. Anyone over a certain age can obtain 'the Freedom' and if you look through the relevant pages on the website at:

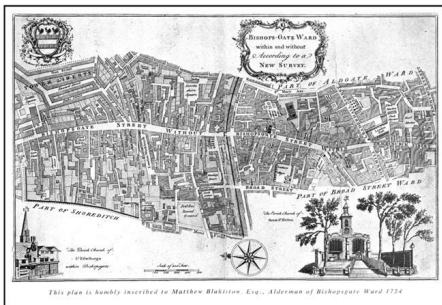

Within the geographical area covered by the Corporation of London there are 25 wards or voting districts. Each ward elects an Alderman and between four and twelve Commoners to represent them in the Court of Common Council, the City of London's town council.

Each of the 25 City wards has one Alderman. In contrast, the number of Common Councilmen per ward is determined by the size of the electorate.

Both Aldermen and Common Councilmen also need to be Freemen of the City at the dates of nomination and election to qualify.

The Goldsmiths' Company, which since 1300 has been responsible for assaying (testing for purity) and marking gold and silver wares. From 1478 these wares were required to be brought to its hall for testing, the origin of the word 'hallmark'. Today the Goldsmiths continue to run the London Assay Office where several million articles of gold, silver and platinum are hallmarked each year.



FREEMEN OF THE CITY

Until 1835 the Freedom of the City - together with membership of one of the ancient guilds which were the forerunners of today's Livery Companies, was essential to anyone who wished to exercise a trade in the City.

A number of ancient privileges are associated with the Freedom - although they are more a product of collective memory than of documented evidence. They include the right to herd sheep over London bridge, to go about the City with a drawn sword, and if convicted of a capital offence, to be hung with a silken rope.

Other advantages are said to have included the right to avoid being press-ganged, to be married in St Paul's Cathedral, buried in the City and to be drunk and disorderly without fear of arrest.

Freemen used to be given a casket in which to keep their Freedom certificate which was a document that was carried around as we would carry a drivers license today.

HONORARY FREEDOM

Honorary Freedom is the highest honour the City of London can bestow. Honorary freemen do not apply for but are invited by the Court of Common Council to take the Freedom. The presentation ceremony usually takes place in the Great Hall of the Guildhall before the Lord Mayor, Aldermen, Common Councilmen and invited guests.

The presentation on these occasions is made by the Chamberlain of London, and is usually followed by a Guildhall or Mansion House banquet.

Famous Honorary Freemen include The Queen, Princess Diana, Nelson Mandela, Florence Nightingale, General Eisenhower, Theodore Roosevelt and Winston Churchill.

Today the Freedom of the City has no real privileges. Prior to 1996, the Freedom was only open to British or Commonwealth Citizens over 21 years of age and of good character. Now however, it has been extended globally, and persons of any nationality may apply either by nomination or by being presented by a Livery Company. There is a long-standing tradition of admitting women, who used to be called 'free sisters'.

In 1959, the islands became a territory within the Federation of the West Indies, but when the Federation dissolved in 1962, the Cayman Islands chose to remain a British dependency.

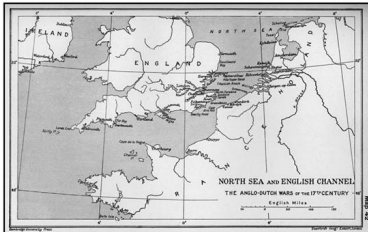
THE CAYMAN ISLANDS



The Cayman flag background is blue, with the flag of the UK in the upper left corner and the Cayman coat of arms centered on the outer half of the flag. The coat of arms includes a shield with three stars and a scroll at the bottom bearing the motto HE HATH FOUNDED IT UPON THE SEAS.

With no direct taxation, the islands are a thriving offshore financial center. More than 68,000 companies were registered in the Cayman Islands as of 2003, including almost 500 banks, 800 insurers, and 5,000 mutual funds. A stock exchange was opened there in 1997.

THE CHANNEL ISLANDS



The Channel Islands are a group of islands in the English Channel, off the French coast of Normandy. They include two separate bailiwicks: the Bailiwick of Guernsey and the Bailiwick of Jersey.

They are both British Crown dependencies, but neither is part of the United Kingdom. They have a total population of about 158,000. Their respective capitals, St. Peter Port and St. Helier, have populations of 16,488 and 28,310.

St. Peter Port is the capital of Guernsey, as well as the main port of the island. The population was only 16,488 as of 2001. In Guernesiais and in French, historically the official language of Guernsey, the name of the town and its surrounding parish is *St Pierre Port*. The "port" distinguishes this parish from Saint Pierre Du Bois.

MONOPOLY



You'll notice that the game of Monopoly is a literal representation of the game that is being played by the hidden masters. The lower class side of the board has the devalued properties, income tax and jail waiting at the end. The next step up sees you having to pay for utilities, but at the end you get free parking.

You have to be careful in the next step up as you're entering Fleet Street and the City of London, and who is there to try and stop you? It seems also that the Super Tax is only really double what the lower class are paying, but the house value has increased more than six times.

The developer of the game, Charles Darrow, is said to have lost his job at a sales company following the Stock Market Crash of 1929.

Monopoly was based on The Landlord's Game, which was a board game patented in 1904 by Elizabeth Magie.

THE TEMPLE CHURCH

The Temple Church was built by the Knights Templar in two parts: the Round and the Chancel. The Round Church was consecrated in 1185 and modeled after the circular Church of the Holy Sepulcher in Jerusalem. The Chancel was built in 1240. The Temple Church serves both the Inner and Middle Temples (see below) and is located between Fleet Street and Victoria Embankment at the Thames River. Its grounds also house the Crown Offices at Crown Office Row. This Temple "Church" is outside any Canonical jurisdiction. The Master of the Temple is appointed and takes his place by sealed (non-public) patent, without induction or institution.



ORDER OF THE KNIGHTS TEMPLAR

The Knights Templar were originally formed by the Catholic Church during the time of the Crusades. Their purpose was to reclaim the Holy Land of Israel, the Spiritual home of the Jews. They were later persecuted and killed upon order of the Pope.

Recently, the Association of the Sovereign Order of the Temple of Christ, whose members claim to be descended from the legendary crusaders, filed a lawsuit against Benedict XVI calling for him to recognise the seizure of assets worth 100 billion Euros.

They claim that when the order was dissolved by his predecessor Pope Clement V in 1307, more than 9,000 properties as well as countless pastures, mills and other commercial ventures belonging to the Knights were appropriated by the church.

They say their motive is not to reclaim damages, only to restore the "good name" of the Knights Templar.

"We are not trying to cause the economic collapse of the Roman Catholic Church, but to illustrate to the court the magnitude of the plot against our Order," said a statement issued by the self-proclaimed modern day Knights.

I found this company data, but again it is unclear if this is the actual Knights Templar or not.

VATICAN AND THE OVAL OFFICE



An Egyptian Obelisk surrounded by a circle of standing stones in St. Peters Square, Vatican City.

The Obelisk at the Vatican is perhaps one the most important pieces of the puzzle if we are to discover the real meaning behind the global elite's plans.

To properly explain this, I'm going to need to give you a bit of a history lesson, one which you have probably never heard before.

Quarried in Egypt during the 13th Century BC, the Obelisk was originally brought to Rome in the 1st Century. In 1586, the Italian engineer Domenico Fontana moved the Egyptian Obelisk to its present site in front of the Vatican in St. Peter's Square.

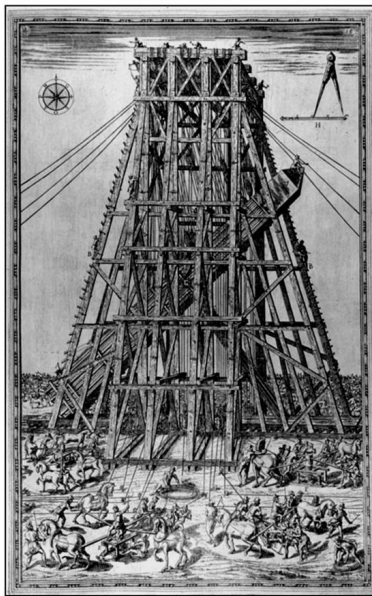
It originally stood in The Circus of Nero or "Caligula's Circus", which was the site of the first organized, state-sponsored martyrdoms of Christians in 65AD. It was a large oval open-air venue used for public events in the ancient Roman Empire.

Along with theatres and amphitheatres, Circuses were one of the main entertainment sites of the time. The performance had a rectangular strip running most of the length down to the middle of the space, creating an oval circuit around the outside.

The strip was called the spina (spine) and usually featured ornate columns, statues and obelisks.

The Obelisk remained there until Pope Sixtus V (December 13, 1521 – August 27, 1590), as part of his plan to continue the construction of St. Peter's, recommended moving it 275 yards from its original site to where it still sits today, in front of the Vatican more than 400 years later.

It took Fontana a whole year to complete the task and on September 28, 1586, the scaffolding and tower had been removed.



The Obelisk sits at the centre of the Vatican's oval courtyard, which followed in the design of the Circus, and marks the centre of the Union Jack Flag, which as explained in CLASSIFIED is the Union of Jacob.

In 1817 circular stones were set to mark the obelisk's shadow at noon as the sun entered each of the signs of the zodiac, making the obelisk a monument to the Sun.

The red granite Obelisk is 25.5 meters tall, and is supported on bronze lions. The Lion is recognised as the symbol of Israel but many don't realise there are two Jews.

THE ORIGINAL UNITED KINGDOM



The flag of the United Kingdom of Israel. This is the same symbol that appears on the UK and Netherlands Royal Crests.

THE CHIGI FAMILY

An often overlooked element is that the Vatican Obelisk is surmounted by the Chigi arms in bronze.

Chigi-Albani is a Roman princely family of Sienese extraction descended from the counts of Ardenghesca, which possessed castles in the Maremma, southern Tuscany.

The first very prominent member was Mariano (1439-1504), a banker and two times Ambassador of Siena to the Popes Alexander VI and Julius II. He founded the Roman branch of the family, the other branch was started by his brother, Benedetto.

Agostino Chigi (1465-1520) was the most famous member of the family during the Renaissance. He became an immensely rich banker, and built the palace and gardens afterwards known as the Farnesina, decorated by Raphael, and was noted for the splendour of his entertainments.

Pope Julius II made him his finance minister and gave him the privilege of quartering his own (Della Rovere) arms with those of the Chigi.

Ludovico Chigi Albani della Rovere was Grand Master of the Knights of Malta from 1931 to 1951.



The Palazzo Chigi is a palace or noble residence in Rome, overlooking the Piazza Colonna and the Via del Corso.

In 1878 The Palazzo Chigi became the residence of the Austro-Hungarian Ambassador to Italy.

In 1916 it was bought by the Italian state and became the seat of the Minister for Colonial Affairs. Later it was the official residence of the Italian Minister of Foreign Affairs. In 1961 it became the official meeting place of the Council of Ministers whose President is the Italian Prime Minister.

Pope Sixtus V was also instrumental in the excommunication of Queen Elizabeth I of England (1558-1603), and granted a large subsidy to the Armada of King Philip II, but, knowing the slowness of Spain, would give nothing till the expedition should actually land in England.

In this way he was saved his Crown millions, and spared the reproach of having taken futile proceedings against what Roman Catholics viewed as the heretic Queen.

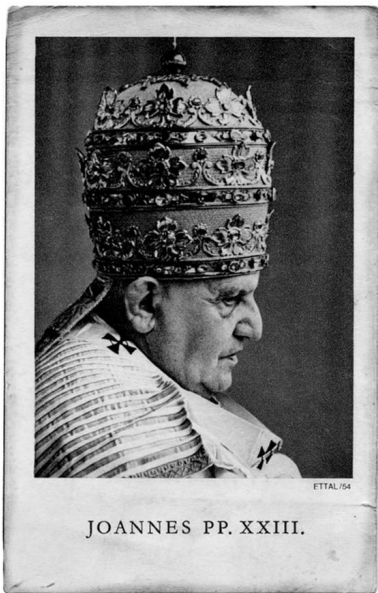
This ex-communication, which Catholics of the day considered richly deserved, was to have been published in England if the invasion had been successful.

It was signed by Cardinal Allen, and is entitled "*An Admonition to the Nobility and Laity of England*". It was intended to comprise all that could be said against Queen Elizabeth I, and the indictment is therefore fuller and more forcible than any other put forward by the religious exiles.

Elizabeth set out to rule by good counsel, and she depended heavily on a group of trusted advisers led by William Cecil, Baron Burghley.

One of her first moves as Queen was to support the establishment of an English Protestant church, of which she became the Supreme Governor. This Elizabethan Religious Settlement held firm throughout her reign and later evolved into today's Church of England.

THREE CROWNS



The Papal Tiara showing the three crowns, obviously signifying control over the trinity of the three city states.



The inscriptions on the Papal Tiara read:
IESV CHRISTI VICARIO INFALLIBILI
ORBIS SVPREMO IN TERRA RECTORI
REGVM ATQVE POPVLORVM PATRI

which translates to:

*To The Infallible Vicar of Jesus Christ
To the Supreme Governor of the World on Earth
To the Father of Nations and Kings*



The above medal celebrates the Lateran Treaty of 1929, by which Vatican City was formally recognized again as a political state, with the Pope as its absolute monarch. A bust of the Pope is on the front, and on the reverse is the apostle Peter, with the keys of authority, depicted as having global dominion from his seat, the Vatican City, Rome.

As the successor of Peter, Pius XI was symbolically depicted by this medal to be the ruler of the world, and Vatican City to be its capital.

CAPITOLINE HILL



Capitol Hill in Washington DC, the District of Columbia. Almost an exact replica of the Vatican.

Capitoline Hill in Rome was the site of an important temple for the worship of the Capitoline Triad, the group of three supreme deities or Holy Trinity. In Etruscan Mythology they were Tinia, Uni and Minerva (later Athena). Originally it was Jupiter, Mars and Quirinis

Jupiter, from the latin Lou & Pater meaning Jupiter Father, was the King of the gods and ruled over laws and social order. Mars was the Roman warrior military god. Quirinis was the Sabine god of War. Plato also associated Athena with Neith, the Goddess of War.

The term Magistrate comes from Rome and was originally the King who was Chief Executive, Priest and Law giver.

THE WHITEHOUSE CONNECTION

In the arts, the Baroque was a Western cultural period, starting roughly at the beginning of the 17th century in Rome, Italy. The Oval Office at the Whitehouse represents the Military arm of the union or Trinity.

The oval interior design is a Baroque concept that was adapted by Neoclassicism. The popularity and success of the Baroque style was encouraged by the Roman Catholic Church for it's symbolic connection to Caligula's Circus.

The desk used by many presidents in the Oval Office is called the Resolute desk, so named because it was built from the timbers of the British frigate HMS Resolute.

The desk was a gift of Queen Victoria of the United Kingdom to President Rutherford B. Hayes in 1880.

It also features prominently in the film National Treasure with Nicholas Cage.

In March 2009, British Prime Minister Gordon Brown presented US President Barack Obama with the framed commission of HMS *Resolute*, and a pen holder made from the wood of another navy ship, HMS Gannet. The desk therefore is a symbol of Admiralty and represents the head of the fleet.

A Jack is the flag of a Nation flown by warships at the head of the ship.

SUPREME KNIGHT

Carl A. Anderson is the 13th Supreme Knight, appointed by Pope John Paul II to the Pontifical Academy for life.

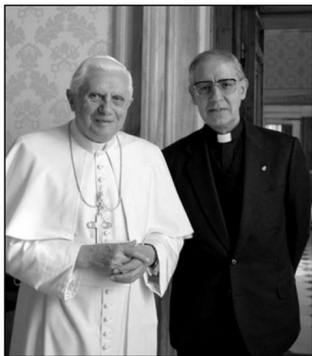
A member of the Vatican Delegation of Catholic-Jewism. During the Reagan administration, he served as Executive Office of the President, and is admitted to practice law at the U.S Supreme Court.

JESUITS AND THE BLACK POPE



It has been suggested that the real source of control and power in the world today are the Jesuits, or Society of Jesus, a military organisation under the control of the Roman Catholic Black Pope. Adolfo Nicolas was elected the Jesuits "Black Pope" on the 19th Jan 2008.

Saint Ignatius of Loyola was the Founder of the Jesuits and was born in the Basque region of Spain in 1491, the youngest of thirteen children.

After an unsuccessful attempt to go to Jerusalem as missionaries, the men, calling themselves the *Compania de Jesus* (Society of Jesus) went to Rome and put themselves at the disposal of the Pope.

Their rule of common life was approved by Pope Paul II September 27, 1540, and Ignatius, as superior of the new religious order, governed, recruited, and wrote many letters. He completed writing the Jesuit Constitutions in 1551.

Soon the Society was established in Spain, Portugal, France, the Low Countries, and Germany. Jesuit missionaries were sent to Africa, India and North and South America.

From 1795 the Jesuits have controlled England and the world.

When Rothschild sent Roost to London, saying that Napoleon had won the Battle of Waterloo, that's when the stock market plummeted, and the Jesuits bought up all the stocks in London gaining control of the Bank of England.

London then became the commercial center of the world with Rome as their religious center with the intention to re-establish Jerusalem.

The purpose of the Knights of Columbus was also to fulfill Jesuitical politics, and part of those politics was to restore the temporal power of the Pope.

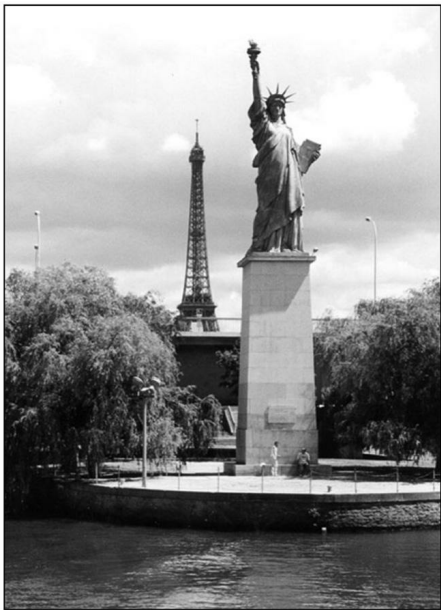

THE FRENCH CONNECTION



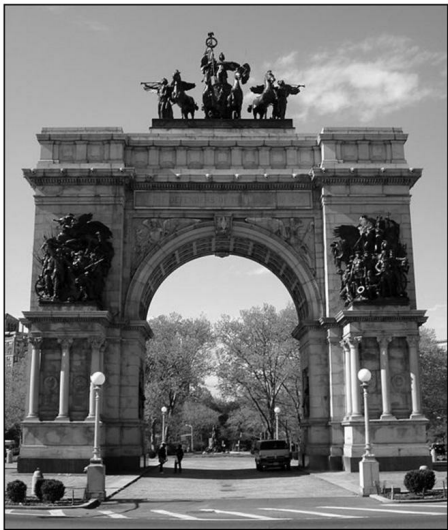
Place de la Concorde Egyptian Obelisk which Princess Diana Passed by moments before her arranged death.

On July 4, 1889 the American community in Paris offered the French people a gift of a bronze replica of the Statue of Liberty. A declaration delivered by French Ambassador Jule J. Jusserand at the 1916 ceremony stated: "*Not to a man, not to a nation, the statue was raised. It was raised to an idea - an idea greater than France or the United States: the idea of Liberty.*"

The other important symbol of course is the Arch, which can be seen in New York, Rome and France. The original Arch of Titus was brought back from Jerusalem and stands to this day in Rome.

The Society of Jesus was thenceforth recognized as the chief opposing force of Protestantism, which brings me to the Gunpowder plot. Guy Fawkes, a Jesuit Priest was sent to London to try and blow up Parliament and the Protestants (the protestors against Roman Rule).

As a child growing up in England, I always wondered about the real meaning of this ritualistic burning, but had no idea at the time just how deep the meaning was. I just enjoyed the fireworks.

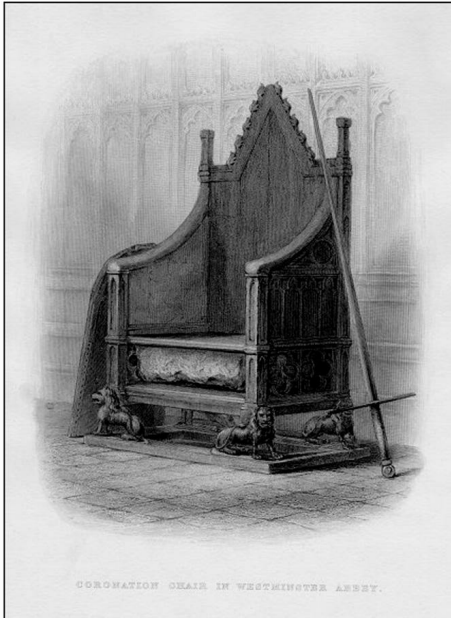

The Gunpowder Plot of 1605 was the Jesuits attempt to destroy King Solomon, King James I, along with the entire Protestant Parliament by sending Guy Fawkes to try and blow up the building. Remember, Elizabeth I had expelled the Jesuits from her Empire, and if they were ever caught they were to be drawn and quartered. Many people have wrongly sided with the symbolic figure of V thinking he is an enemy of the government, when in fact he is the enemy of freedom.

ORIGINS OF THE CORONATION



The Coronation Throne in Westminster Abbey with Jacob's Stone and Lions of Israel supporting it.

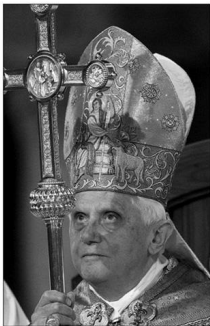
A Coronation is a ceremony marking the investiture of a monarch with regal power, specifically involving the placement of a crown upon his or her head, and the presentation of other items of regalia.

The Pharaohs of Ancient Egypt were believed to be directly descended from the gods. These deities were believed to confer special powers upon the ruler, all of which were essential to maintaining earthly and cosmic order.

A Pharaoh's Coronation was not merely a rite to proclaim him as King or to legitimize his political right to rule; it literally facilitated the transmission of these unearthly powers to the new Egyptian ruler.

In this ceremony, the king was transformed into a god by means of his union with the royal *ka*, or life-force of the soul.

All previous kings of Egypt had possessed this royal *ka*, and at his or her coronation, the monarch became divine as "one with the royal *ka* when his human form was overtaken by his immortal element, which flows through his whole being and dwells in it". This made him the son of Ra, the sun god, Horus, the falcon god, and Osiris, the god of life, death and fertility.



Note the Dogon Fish-God headpiece the Pope wears.

From the Middle Kingdom on, the Pharaoh also came to be seen as the son of Amun, the King of Egyptian gods, until his cult faded in later centuries.

Upon the death of the reigning Pharaoh, his successor was named immediately, so that the nation's cosmic protection would continue unbroken.

While the new monarch ascended the throne the very next day, the coronation ceremony did not take place until the first day of a new season, thus symbolising the beginning of a new era.

The ceremony was usually carried out at Memphis by the high priest, who invested the new king with the necessary powers to continue his predecessors' work.

As a permanent reminder to his people of his divine birthright, the Pharaoh wore various elements of royal regalia that varied depending upon the particular period in Egyptian history.



The Coronation of Queen Elizabeth II. Notice the Throne with Jacobs Stone and the symbolic stepped pyramid.

Among these were a false beard made from goat's hair, identifying him with the god Osiris; a sceptre shaped like a shepherd's crook known as a Heka, which meant "ruler" and was often associated with magic; and a fly whip called the *Nekhakra*, symbol of his power and authority.

The new monarch also wore a *Shemset* apron, while his back was protected by a bull's tail hanging from his belt, symbolic of strength, though this was later done away with.

Ra-Herakhty had been a solar deity and this nature became ascribed to Amun-Ra as well, Amun becoming considered the *hidden* aspect of the sun during the night, in contrast to Ra-Herakhty as the *visible* aspect during the day.

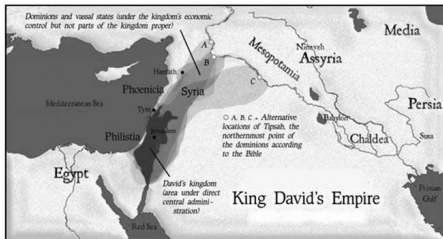
Amun clearly meant *the one who is hidden*. This complexity over the sun led to a gradual movement toward the support of a more pure form of deity.

The Word Amen, spoken after prayers, comes from the worship of the Sun God.

KING DAVID

David was the second King of the united Kingdom (of Israel) The Monarchy of the House of David is especially relevant to Kings and Queens such the British Royal Family and House of Orange claiming Royal lineage and to major leaders in Jewish history, it is also relevant in a general sense to anyone who claims descent from King David.





JACOBS STONE

Esau was the brother of Jacob (who was renamed Israel) the patriarch and founder of the Israelites in the biblical Book of Genesis. Esau was the oldest son of Isaac and Rebekah and the grandson of Abraham.

Jacob and Esau were fraternal twins.

Rebekah gave birth to Esau first and Jacob second, who was apparently holding onto Esau's heel. This traditionally entitled Esau to inherit the wealth of his father after his death. I usually don't quote bible scriptures, but this following passage is important.

Genesis 25:22-23,

"And the children struggled together within her; and she said, If it be so, why am I thus? And she went to enquire of the Lord. And the Lord said unto her, Two nations are in thy womb, and two manner of people shall be separated from thy bowels; and the one people shall be stronger than the other people; and the elder shall serve the younger."

Jacob had twelve sons and one daughter by his two wives, Leah, Rachel, and their maidservants, Bilhah and Zilpah. His sons were: Reuben, Simeon, Levi, Judah, Dan, Naphtali, Gad, Asher, Issachar, Zebulun, Joseph, and Benjamin, and his daughter was called Dinah.

These are the 13 tribes of Israel. The true source of the number on the dollar bill.



Jacob is said to have used a stone for a pillow the night he wrestled with God. After God changed his name to Israel, he then used it as a pillar to mark the covenant he made him.

Hence the term British. "Brit" – meaning Covenant and "Ish" meaning Man.

Jacob's Pillar Stone was to play a vital roll in the following three predicted overturnings of the throne of David.

The Stone remained in Jerusalem until after 586 B.C. when Jerusalem was destroyed, it was taken by Jeremiah to Ireland via the Rock of Gibraltar, with the daughter of Zedekiah. After this time, the Kings of Ireland would all be crowned while seated upon the Pillar Stone of Jacob.

When the throne of David was overturned a second time to Scotland, the Stone was taken to Scotland by the first Scottish King, Fergus, in the ninth century, and placed at the ancient capital of Scone. The Scottish Kings were also crowned while seated upon it.

The Stone of Jacob was seized by King Edward I in 1296, and has been used in the coronation of every English monarch since that time. Queen Elizabeth II was crowned while sitting on the Coronation Throne containing the Stone of Jacob. Until recently, the Stone of Jacob has sat under the Coronation Chair in Westminster Abbey.

In 1996, in a symbolic response to growing dissatisfaction among Scots at the prevailing constitutional settlement, the British Conservative Government decided that the Stone should be kept in Scotland when not in use at coronations, and on the 3rd July 1996 the Stone was returned to Scotland, and on the 15th November 1996, after a handover ceremony at the border between representatives of the Home Office and of the Scottish Office, it was transported to Edinburgh Castle where it remains on display.

THE STONE OF DESTINY

The Lia Fáil (Irish for *Stone of Destiny*) is a standing stone at the Inauguration Mound on the Hill of Tara in County Meath in Ireland, which served as the coronation stone for the High Kings of Ireland. In legend, all of the Kings of Ireland were crowned on the stone.

There has been much comment that the stone being transferred was not the real stone at all, but a replica which had taken its place either in the 13th century or in the 1950s.

The stone of Scone was recently tested and stated to be of the sandstone found in the area of Scotland and Scandinavia.

Whether this signified that it was not the original, or that it was the Lia Fail that was the stone allegedly brought to Ireland by the Tuatha De Danaan when they returned to Ireland from their sojourn in Denmark is unknown.

It has remained with the descendants of Israel since the time of Jacob, and the Royal Seed of David have always been crowned upon it.

THE SERPENT KING

The King of Ammon, was called Nahash, and was the King of the Ammonites at the time of Saul. Nahash is a word that in several Semitic languages, means *serpent*. I believe this is the reason we see so much Serpent Symbolism around London and in Illuminati controlled corporation logos such as the Alfa Romeo(o) with the serpent (or perhaps dragon) swallowing a human being alongside the Flag of St George.



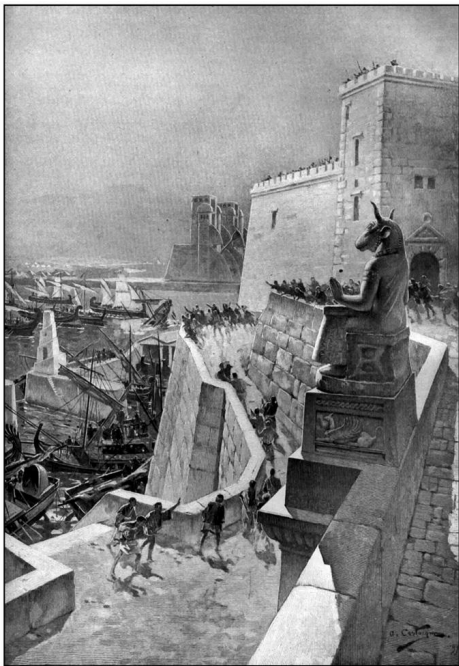
He was the first King of the United Kingdom (of Israel) according to the Hebrew bible, and you can now see where the modern term for England comes from. According to the Bible, Kings in Biblical Israel were crowned and anointed, most often by a prophet or high priest.

According to the Tanakh, Saul was the son of Kish, of the family of the Matrites, and a member of the tribe of Benjamin. Benjamin in the Book of Genesis, is a son of Jacob.

The place of *Gilgal* is a figurative location given to the place of rest to all of Israel which includes both physical and spiritual Israel. They are those that fight with the Lord upon his return. After slaying all of sinful humanity in the last battle, all of God's remaining children return to Gilgal for eternal rest. Keep that in mind regarding the 144,000.

Of the customs, religion, and social structure of the Ammonites, little is known, however except for the name of their chief deity, Milcom (Molech). In the Bible Milcom is described as having been worshipped with human sacrifice.

The main mention of Gilgal is when the Book of Joshua states that the Israelites first encamped there after having crossed the Jordan River. In the narrative, after setting up camp, Joshua orders the Israelites to take twelve stones from the river, one for each tribe, and place them there *in memory*. Joshua is the individual who anoints David as King.

The Coronation ceremony was held at Gilgal, which was also the location where he offered sacrifices. Gilgal literally means “*circle of standing stones*” which is obviously where the Irish and English stone circles originated.

STONEHENGE



I therefore believe that Stonehenge was originally the site of midsummer solstice rituals, which involved the burning of human sacrifices, the same as those, which are re-enacted symbolically every year at Bohemian Grove, in worship of Molech.

New archaeological evidence found by the Stonehenge Riverside Project indicates that Stonehenge served as a burial ground from its earliest beginnings. The dating of cremated remains, found that burials took place as early as 3000 BC.

Stonehenge has been interpreted as functioning as an enclosed cremation cemetery at this time, the earliest known cremation site in the British Isles.

The symbolic Bohemian Grove sacrificial ceremony where an effigy of a child is burned is called the Cremation of Care. Their catchphrase being “*Midsummer sets us free*”.

Stonehenge itself is owned by the Crown and managed by English Heritage, while the surrounding land is owned by the National Trust.

THE DRUIDS



The Ancient Order of Druids (AOD) that meets there was founded in England in 1781 as a secret society, similar to the Freemasons.

The north eastern entrance of Stonehenge was widened at that time so that it precisely matched the direction of the midsummer sunrise.

In Great Britain from the 13th century onwards, Midsummer was celebrated on Midsummer Eve (St. John's Eve, June 23) and St. Peter's Eve (June 28) with the lighting of bonfires.

The Feast of St. John coincides with the June solstice also referred to as Midsummers. The Christian holy day is fixed at June 24, but, in the old way, festivities are celebrated the night before, on St. John's Eve.

The Wicker Man was a large wicker statue of a human used by the ancient Druids (priests of Celtic paganism) for human sacrifice by burning it in effigy, according to Julius Caesar in his *Commentarii de Bello Gallico*.

Caesar mentions the wicker man as one of many ways the Druids of Gaul performed sacrifices.

A druid was a member of the priestly and learned class active in Gaul, and perhaps in Celtic culture more generally, during the final centuries BCE.

They were suppressed by the Roman government from the 1st century CE and disappeared from the written record by the 2nd century, although there may have been later survivals in Britain and Ireland, since druids feature prominently in Irish mythology.

Little contemporary evidence for them exists, and thus little can be said of them with assurance. Most of what is known about them comes from the Roman writers.

They may have combined the duties of priest, judge, scholar, and teacher. The core points of druidic doctrine known to us from Roman sources is their practice of human sacrifice.

Human sacrifice was the reason why druidism, unlike other national religions within the Empire, was outlawed under Tiberius.

ST. PATRICKS DAY



St. Patrick's Day is a holy day of obligation for Roman Catholics in Ireland. The occasion marks the annual Festival of Tara, also known as Baal's Fire.

After some research, I discovered the true meaning of St. Patrick's Day, which is the celebration of the victory by Saint Patrick over the Druids practice of human sacrifice and ritualistic burning at midsummer solstice, known as "Baal's Fire".

The Druids brought this ritual of the Sun and the god Baal with them from Gaul, but it obviously dates from earlier periods such as Gilgal and Israel. This is the origin of the cremation of care rituals that take place each year at Bohemian Grove. The Druids were also known as "The Priests of the Groves".



The lucky cloverleaf comes from his teachings of the Trinity, which he demonstrated using a three leaf clover.

In Irish mythology, the Tarbhfhess, the bull-sleep was a ritual closely associated with the Druids. A selected individual was fed on bull flesh before being chanted to sleep by four Druids; while he slept he dreamt of the next rightful High King of Ireland and when he awoke he gave this information to his Druid attendants.

BELTANY



The remains of the Beltany stone circle in Ireland.

Beltany standing stone circle is located in a field a few miles outside of Raphoe, County Donegal. The stones date from 2000BC. The circle is 44m in diameter and has 64 stones in it.

The circle also contains a tumulus, which may also have been a burial site as remains have been excavated there.

This megalithic monument is situated on a prominent hill top.

The Irish name Beltany is from 'Baal Tine' - 'Baal's Fire' - the pagan practice of sun worship.

The Great Baal was of the land of Canaan.

He was the son of El, the high god of the Canaanites. The cult of Baal celebrated his death and resurrection annually as a part of the Canaanite fertility rituals. These ceremonies often included human sacrifice and temple prostitution.

The Israelites also practiced the abominable ritual sacrifice of burning their first born children alive (known as "passing through the fire") at Gehenna in Jerusalem.

THE VALLEY OF HINNOM

The religious notion of Hell, as a fiery terrible place where you burn forever for your sins, is in fact nothing more than a reference to a real place in the Valley of Hinnom in Jerusalem. The site is called Gehenna.

Hinnom is one of the two principal valleys surrounding the Old City.

Gehenna is cited in the New Testament and in early Christian writing to represent the place where evil will be destroyed. It lends its name to Islam's hell, Jahannam. In both Jewish and Christian writing, Gehenna as a destination of the wicked is different from Sheol, the abode of the dead.

In ancient times, children were sacrificed to the pagan god Molech, a practice that was outlawed by King Josiah.

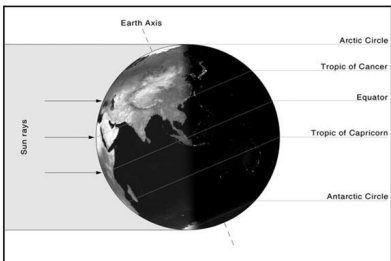
It is said that priests would bang on drums so the fathers would not hear the groans of their children being burnt alive.

The valley therefore, became extremely offensive; the sight was horrific; the air polluted with the foul smell of putrefying animal and human flesh; and to preserve it in any manner pure, it was necessary to keep fires continually burning, hence the eternal flame and eternal damnation.

After the return of the Jews from captivity, the valley was held in such abhorrence that it was made the place to throw all the dead carcasses and filth of the city, and was frequently the place of public executions. It became the garbage dump of the city.

The Valley of Hinnom is located below the southern wall of ancient Jerusalem. It stretches from the foot of Mount Zion eastward to Kidron Valley.

SOLSTICE



A solstice is an astronomical event that occurs twice each year, when the tilt of the Earth's axis is most inclined toward or away from the Sun, causing the Sun's apparent position in the sky to reach its northernmost or southernmost extreme.

The name is derived from the Latin *sol* (sun) and *sistere* (to stand still), because at the solstices, the Sun stands still in declination; that is, the apparent movement of the Sun's path north or south comes to a stop before reversing direction.

There is a great deal of symbolism and reference to the Sun. Sunday is an obvious one, but did you know that Saturday comes from the worship of the planet Saturn (in actuality Saturn-day).

The daughter of Saturn was Juno, also called Regina (Queen) a term, which is still used to this day by Elizabeth Windsor (Saxe-Coburg-Gotho).

The Trinity consisted Jupiter, Juno and Minerva.

Interestingly, the ANZ Bank has a holding company called Minerva Holdings, located at Minerva House in London.

Minerva was the Roman name of the Greek goddess Athena. She is often depicted with an owl, her sacred creature and a symbol of wisdom.

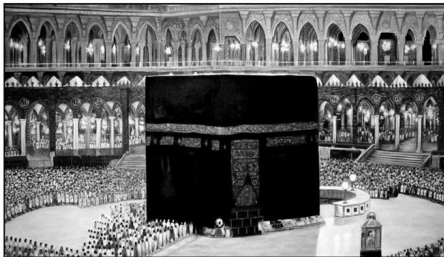
This is the origin of the owl on the dollar bill and the logo of the Bohemian Club.

Minerva was worshipped on the Capitoline Hill as one of the Capitoline Triad along with Jupiter and Juno, at the Temple of Minerva Medica.

The modern term Matron, that you find in the delivery ward of the hospital comes from the festival of Matronalia, a celebration of the Goddess of Child Birth, Juno, and celebrated on March 1st.

SATURN

The most holy place in Islam is the black cube known as the Ka'aba at Mecca which was *originally* a shrine to the planet Saturn. Hassidic Jews and Jewish Rabbis wear black robes because 'Yahweh' is Saturn. The Black Stone, which is a meteorite, is cemented into the base next to a symbolic pyramid.

It has long been known that Saturn was the god of the Jews. In more recent times, for instance, Carl Jung knew very well that Saturn was the "Star of Israel" (ie. the Star of David). Throughout the Middle Ages, the Jews were largely known as the People of Saturn. Saturn is frequently called the "black", or "dark", planet, or the Black Sun. It seems that people once believed that Saturn shone like a sun, but was the hidden one. Saturnalia was a feast dedicated to Saturn, and was a license with careful boundaries where masters and servants changed places for the day. Saturn was named after the Roman god Saturnus.

SEMIRAMIS

The Statue of Liberty is supposedly one of the most recognizable and well-known symbols of freedom, or is it?

The Statue of Liberty was a gift by the French Freemasons. Embossed in Roman numerals on her tablet is the date 1776 – the date of the Declaration of Independence from England.

Built upon the sea, not upon the land, she also represents the law of the Sea, or Admiralty.

I believe that the Statue represents both the worship of the Sun and also the personification of the Babylonian goddess of war, a woman known as Semiramis.

She can be seen represented in many places, sometimes hidden in plain sight. Some of the names she is commonly known by are Columbia, The Triple Goddess, Tri-Star, Amazon Queen, The Spear Shaker, and of course Liberty.

We have been led to believe that the Dove is the symbol of freedom, which The Statue of Liberty is also supposed to stand for.

In fact, in this context as you can see, it is in fact a symbol of WAR. There is a big difference between liberty and freedom, one is given by a master, the other is a natural inalienable right.

I would like to draw your attention to the image on an old Babylonian coin and compare it with the proposed Amero currency that is set to replace the US dollar. Not only does the figure in the Babylonian coin wear the same headdress as the Statue of Liberty, but in the newer coin, she even bears the name Liberty.



You can see her pictured here with her torch (Illuminated Ones) and her strange robe top appears to mimic the outline of North America on the right side.

Behind her is the cogged wheel, often seen in Nazi German logos, her spear, and the world tossed aside. On the reverse, the Nazi Eagle stands atop the world, which I talk about later in the book in regards to Australia's symbolic place in all of this as part of the Common-wealth.

Interestingly, and for those who believe that Shakespeare was really Sir Francis Bacon, here's some interesting facts. Semiramis was known as the Spear Shaker, and Bacon was Authorised by King James to oversee the new version of the Bible.

If you get a copy of the Authorised King James Bible, you can turn to Psalm 46 (Bacon was 46 when he created what is known as the Bacon Cipher) and if you count 46 words from the start, you will come to the word "Shake" which used to say "quake", and if you count 46 words back from the end, you come to the word "Spear" which used to say "shield". In between those two words are exactly 111 letters. 111 is the name of Bacon's famous Cipher. Bacon was also the founder of a great many secret societies including the Rosicrucians (Rose Croix - Red Cross).

For more details on this I would suggest Manly P Hall's Secret Teachings of all ages, which includes the Bacon Cipher.

The first Atomic Test was named Trinity. He is depicted in the Bible as a mighty ruler and nation builder who founded many cities, including the great Babel or Babylon. Despite his stance as a powerful leader, his reputation was tarnished by his traditional association with the construction of the Tower of Babel.



At the time of King Nebuchadnezzar in Babylon, Semiramis was instrumental in the design and building of the Hanging gardens of Babylon, also known as the Hanging Gardens of Semiramis. Nebuchadnezzar destroyed Zion in Jerusalem including Solomon's Temple, the first Jewish Temple.



In the movie *The Matrix*, there is a close up on a plaque, which reads: "Nebuchadnezzar, Mark III No.11 Made in the U.S.A 2069. Mark 3:11 in the Bible reads "You are the son of God".

ANNUNAKI

The so-called "Weidner Chronicle" states that it was Sargon who built Babylon "in front of Akkad". Sargon of Akkad, also known as Sargon the Great was an Akkadian Emperor famous for his conquest of the Sumerian city-states in the 24th and 23rd centuries BC.

Iraq has been the center of the Akkadian, Assyrian, Babylonian, and Abbasid Empires which brings me to the real reason that the US/Vatican are interested in Bagdad. To answer that question, we have to take a look at the tablets of *The Epic of Gilgamesh*.

Tablet Three says" Years later, becoming bored of peaceful life in Uruk, and wanting to make an ever-lasting name for himself, Gilgamesh proposes to travel to the Cedar Forest to cut some great trees and kill the guardian, the demon Humbaba. 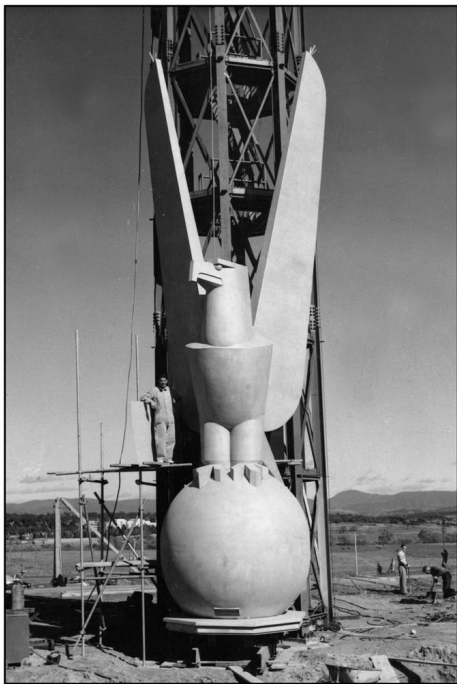
Coat of arms of the First Reich - The Holy Roman Empire

The Reichsadler (Empire's Eagle, or Eagle of the Empire) was a historic eagle national insignia deriving from the heraldic Roman Aquila during various times of Germany's history, including the German Empire, the Weimar Republic and Nazi Germany.

It can be traced back to the banner of the Holy Roman Empire, when the eagle was the insignia of the Imperial power as distinguished from the Imperial states. Before that it was the Coat of Arms of Israel.

RUSSELL OFFICES

Campbell Park, together with Russell Offices, is the headquarters of the Australian Defence Force. It is located in Canberra, the national capital of Australia, in the suburb of Campbell, Australian Capital Territory.

The enormous Obelisk with its Nazi Eagle and globe marks the lower left corner of the pyramid known as the Parliamentary Triangle or "Griffins Triangle" the model of which can be seen on page five, and is named after its architect. The monument's official title is the Australian-American Memorial, and was opened by none other than the Queen.

The image on the front cover is the Eagle being fabricated at a workshop in Sydney.

The building looks eastward across the Majura Valley and Canberra International Airport and backs onto Mount Ainslie. The offices have seven floors of varying width, staggered back on tall concrete pillars to match and blend with the profile of the hill to the west. Four numbered sections, numbered from the south, bend slightly eastward at each 'node' where lifts take people between floors.

Nodes B, C, D, and E also have spiral staircases. Access is by main security entrances at B and D Nodes, between CP1&2 and CP3&4 respectively. Underground document storage and work space is below part of the building.

The building has an access road on the hill side and another on the down-hill side near the underground storage areas, near the extensive car parking areas. The precinct is accessed from Northcott Drive, that passes the Australian Defence Force Academy and the Royal Military College, Duntroon to Russell. This crosses Fairbairn Avenue that runs between the airport (formerly the Royal Australian Air Force Fairbairn base) and the Australian War Memorial at ANZAC Parade.

THE MILITARY INDUSTRIAL COMPLEX



The JORN project arose out of extensive research undertaken by the Defence Science and Technology Organisation (DSTO) into over-the horizon radar (OTHR) beginning in the early 1970s.

As part of the 1987 Defence White Paper, the Government placed a high priority on wide area surveillance of the north and northwestern approaches to Australia and OTHR was seen to be the most cost effective solution.

As a consequence, in December 1990, the Government approved the design and construction of JORN.

The Jindalee Operational Radar Network (JORN) consists of two OTHR, one near Longreach, Qld and the other near Laverton, WA, jointly operated from the JORN Coordination Centre (JCC) at RAAF Base Edinburgh, SA by No 1 Radar Surveillance Unit. The radars are an advanced development of the Australian designed Jindalee radar at Alice Springs which is in operational use as well as being a research and development facility used by DSTO for ongoing OTHR improvement.

JORN radars are capable of all weather detection of air and surface targets inside an arc of up to 3,000 km range extending from Geraldton in the west around to Cairns in the east. JORN makes a crucial contribution to broad area surveillance of Australia's strategically important northern approaches.

OMEGA STATION

I couldn't find any photos of the Omega antenna station in Victoria, although I've been aware of it for about 15 years now.

I decided to look for it in Google maps, and it was pretty easy, considering the size of the circular road that surrounds it. I then put that location into Google Earth to take this shot.



The 450 metre tall Omega mast at Darriman, Victoria, is perhaps the largest US top secret military project hidden in the open, carefully disguised as a vaguely inaccurate navigation transmitter dedicated to the worthy cause of maritime emergency services. In reality Omega is an extremely accurate, strategic navigation system emitting an electromagnetic field so powerful it poses a health threat to Australian citizens in Victoria and beyond.

The introduction of Omega to Australia took the US government 13 years to complete. The Victorian transmitter was the last of eight worldwide stations to begin transmitting during late 1982. US strategy was to deceive the Australian government and people alike with disinformation aimed at proving the Omega system was not accurate enough to be used as an aid to nuclear ballistic missile submarines.

TIDBINBILLA TRACKING STATION



The Tidbinbilla tracking station situated close to Canberra in the ACT is the most important deep space system in Australia.

Established under a joint agreement between the United Kingdom, Australia and the USA it is an essential part of the US space programme.

It is also a vital control center for the Hubble orbital telescope. In fact the first images transmitted by the telescope were received by Tidbinbilla and they caused quite some concern.

I have read that a scientific advisor to the Australian Government that was present when the first photographs arrived said they clearly showed solar systems around the closer stars at which the telescope was aimed.

According to this advisor it was possible to discern more than fifty new solar systems in the first few hundred pictures.

It seemed apparent that virtually every star has a solar system of one type or another and the evidence arriving at Tidbinbilla was undeniable.

The revelations caused concern among the control room staff, particularly the Americans who were angered that Australians and British were parties to these revelations.

A meeting was hastily arranged and although all present had security clearances they were told that it was of utmost importance that nothing leaked out and they must not talk about what they had seen.

The Government and industry are working together as "Team Australia" to maximise Australian industry participation in the JSF program. The Government is facilitating contact with prime contractors Lockheed Martin, Northrop Grumman and BAE Systems; and engine contractors General Electric and Pratt & Whitney, through a number of Industry Capability Teams (ICTs).

The ICTs are composed of Australian companies with relevant capabilities and are commercially driven, self supporting and managed, with Government facilitating their activities.

JSF partner companies have communicated to Australia that the team approach presented through the Team Australia approach by Government and industry, particularly the ICT concept is their preferred method of doing business with Australia.

Presenting your company to Lockheed Martin and other JSF partners is an important element in your involvement in this program. It is important that you provide key details including:

- Contact details, including your address and a key point of contact in the company;
- An outline of your company's key discriminating capabilities; competitive advantages; core capabilities; and
- A broad company snapshot, including the quality approvals held and your company's focus and vision.

Some US suppliers may be concerned about the risk of working with remote suppliers because they have not done so before, therefore, any relevant information you can supply to alleviate perceptions of distance will strengthen your case (eg. US presence, transport links, 24hr part shipment etc).

Request for Proposals and contracts are awarded by the major contractors under the JSF to companies that demonstrate "**Best Value**".

DEMONSTRATING BEST VALUE

Lockheed Martin and its major contractors may be considering several companies from each of their eight partner nations (besides the US). Therefore when presenting your company to Lockheed Martin and major subcontractors, there are several key themes to highlight based on **Best Value**, which has been defined by Lockheed Martin using the following key criteria.

- **Sound Technical Approach** — Is the product technologically advanced? Does the US already have equivalent capability in this field? If so, how is yours better? How will the product be designed/manufactured? Is this best practice? What quality accreditation does the company possess?
- **Solid Management Approach** — Does the company have experience (especially leadership experience) in similar major military projects, industrial partnerships and industry groups? Has the company developed a business/project plan for JSF work? What credibility can management cite (awards, growth, history etc)? Outline your business management plan.

THALES GROUP



Thales will open a new hub for its multinational network of Battlespace Transformation Centre's (BTCs) on 27 September. The new BTC will be located at a Thales facility in Huizen, the Netherlands, joining other BTCs located in Australia, France, Germany, Greece, Singapore and the UK.

Established for 45 years in the United States, Thales currently provides 90% of the navigation infrastructure for US national airspace. Already established in Australia as a trusted partner of the Defence Force, Thales has a rapidly growing commercial business ranging from air traffic management to advanced security technologies.

The following two companies have moved on into South Australia and have made themselves at home. I have even heard word that our namesake The Festival State, may be changed to The Defence State.

RAYTHEON

Raytheon Company is a major American defence contractor and industrial corporation with core manufacturing concentrations in defense systems and defense and commercial electronics. It was previously involved in corporate and special-mission aircraft until early 2007. Raytheon is the world's largest producer of guided missiles.

Established in 1922, the company reincorporated in 1928 and adopted its present name in 1959. The company has around 73,000 employees worldwide and annual revenues of approximately US\$20 billion. More than 90 percent of Raytheon's revenues were obtained from defense contracts and, as of 2007 it was the fifth largest defense contractor in the world and is the fourth largest defense contractor in the United States by revenue.

Raytheon's vision is to be Australia's premier Mission Systems Integrator and Mission Support agent delivering world-class performance to its customers.

HALLIBURTON

Controversy follows the US giant Halliburton wherever it goes but little is known about its Australian operations. The Adelaide-to-Darwin rail link, partly owned by the controversial Texan energy giant and military contractor Halliburton is used to transport radioactive uranium.

Halliburton is now under investigation by the US Nuclear Regulatory Commission for not reporting the loss of the americium earlier.

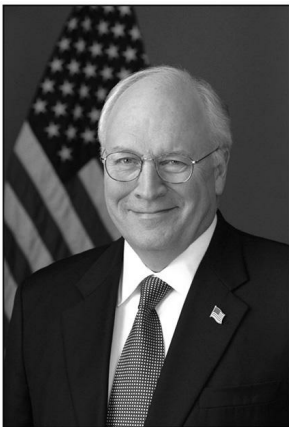
The Australian activities of Halliburton range from the Adelaide-to-Darwin railway to hundreds of secret Defence projects to management of the Australian Grand Prix.

Halliburton's Australian operations have never attracted much attention here, although in recent years this controversial US company has made headlines around the world for all the wrong reasons.

Headed by Dick Cheney, the US Vice-President, before he joined the White House, Halliburton holds about \$US10 billion (\$12.7 billion) worth of defence contracts in Iraq and Afghanistan, making it by far the biggest corporate winner in Bush's war on terrorism.

Halliburton's involvement in Australian defence industries has grown exponentially in recent years.

In 2003 the Defence Minister, Robert Hill, commissioned a report on overhauling the Defence Materiel Organisation (DMO), the operation responsible for procuring military hardware.

During the US election campaign, it was revealed that Halliburton had paid Cheney more than \$US2 million in pension payments since he resigned as the boss in 2000. Protesters in the US have alleged the payments are linked to contracts handed to Halliburton during the Iraq war. The US Government Accountability Office found that Halliburton's contract to reconstruct Iraqi oil fields was awarded without full and open competition.

Other allegations against the company - which reported \$US16 billion revenue in 2003 - are under investigation in the US and elsewhere. In May last year, a Pentagon auditor alleged that a Halliburton subsidiary, Kellogg Brown & Root (KBR), overestimated the price of feeding soldiers in Iraq by \$67 million. The US Army withheld payments until last month, when that decision was overruled by the Pentagon.

Hill appointed the 2003 South Australian of the Year, Malcolm Kinnaird, to head the review team.

Kinnaird was a consultant for Halliburton's KBR Australia subsidiary and had been a director from 1979 to 1999. He is still a KBR consultant and has a joint company, Kinhill Investments, with the US giant.

WOOMERA

Woomera is synonymous with the testing of long-range missiles and rockets during the Cold War, and the launch and tracking of spacecraft in the early days of the Space Age.

Today, the Woomera Test Facility in South Australia is a strategic defence asset used mainly for aerospace test and evaluation activities.

Woomera Prohibited Area (WPA) is a weapons-testing range located in central South Australia, with its southeastern corner located approximately 450 kilometres (280 miles) north north-west of Adelaide.

The Woomera Prohibited Area has an area of 127,000 square kilometres (49,000 sq mi) and is the largest land-based defence and aerospace range in the world.

It remains the largest land-based range in the world.

The facility is administered by the Department of Defence and hosts a wide spectrum of ground, air and space activities for Australian and International government and commercial organisations.

PINE GAP

Pine Gap is located within about 230 km (143 miles) of the geographical center of the continent, 18 kilometers south-west of the town of Alice Springs (The Northern Territory of South Australia), at the foothills of the southern slopes of the MacDonnell Range.

Pine Gap is a satellite tracking station operated by Australia and the U.S. It consists of a large computer complex with eight radomes protecting antennas, and has over 800 employees.



Pine Gap is entirely financed by the US Government, and is officially known as the Joint Defence Space Research Facility.

Pine Gap is officially called the Joint Defence Space Research Facility.

It is believed to be one of the largest ECHELON ground stations and appears to be physically and operationally similar to the signals intelligence facilities at Buckley Air Force Base, Colorado and Menwith Hill, United Kingdom. U.S. Government personnel at Pine Gap are believed to be mostly from the National Security Agency and subordinate service-associated agencies, and the Central Intelligence Agency.



ECHELON

ECHELON is a name used to describe a signals intelligence (SIGINT) collection and analysis network operated on behalf of the five signatory states to the UK-USA Security Agreement (Australia, Canada, New Zealand, the United Kingdom, and the United States, known as AUSCANZUKUS).

The European Parliament states that the term ECHELON is used in a number of contexts, but that the evidence presented indicates that it was the name for a signals intelligence collection system.

ECHELON is capable of interception and content inspection of telephone calls, fax, e-mail and other data traffic globally through the interception of communication bearers including satellite transmission, public switched telephone networks (which carries most Internet traffic) and microwave links.

On 15 February 2007, it was announced that a new US military communications base would be built in Geraldton, after three years of secret negotiations between the US and the Australian Federal Government.

Echelon is allegedly capable of detecting keywords in telephone conversations and emails such as bomb, Allah, president, assassination, plot etc and once intercepted, begins to record and trace the call for examination and Intel.

NURRUNGAR



Joint Defence Facility Nurrungar (JDFN), located on the edge of Island Lagoon, approximately 15 km south of Woomera, South Australia is a facility operated jointly by the Australian Department of Defence and the United States Air Force from 1969 through 1999. Its official area of emphasis was space-based surveillance, in particular the early detection of missile launches and nuclear detonations using U.S. Defense Support Program satellites in geostationary orbits. The name Nurrungar derives from an aboriginal term meaning "listen".

MARALINGA

Maralinga and Emu Field were the scene of UK nuclear testing in the 1950s and as a consequence were contaminated with radioactive waste.

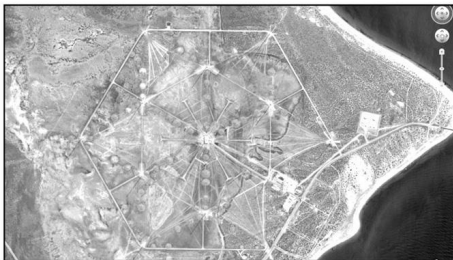
On September 27, 1956, Operation Buffalo commenced at Maralinga, as Emu Field was considered too remote. The operation consisted of the testing of four fission bombs, codenamed One Tree, Marcoo, Kite and Breakaway. One Tree and Breakaway were exploded from towers, Marcoo was exploded at ground level and Kite was released by a Royal Air Force Vickers Valiant bomber from a height of 30,000 ft (9,144 m). This was the first launching of a British atomic weapon from an aircraft.

Operation Antler followed in 1957. Antler was designed to test the triggering mechanisms of the weapons. Three tests began in September, codenamed Tadge, Biak and Taranaki. The first two tests were conducted from towers, the last was suspended from balloons. Yields from the weapons were 1 kiloton, 6 kilotons and 25 kilotons respectively.

TOWER ZERO



Naval Communication Station Harold E. Holt is located on the northwest coast of Australia, 6 kilometres (4 miles) north of the town of Exmouth, Western Australia. The town of Exmouth was built at the same time as the communications station to provide support to the base and to house dependent families of U.S. Navy personnel.

The station provides very low frequency (VLF) radio transmission to United States Navy and Royal Australian Navy ships and submarines in the western Pacific Ocean and eastern Indian Ocean. With a transmission power of 1000 kilowatts, it is the most powerful transmission station in the Southern hemisphere.

The station features thirteen tall radio towers. The tallest tower is called "Tower Zero" and is 387 metres high.

The base is currently operated under contract by Boeing Australia, Ltd, and on the 15th July 2008, Australia and the US signed a bilateral treaty governing the future joint use of the facility for the next 25 years.

In October Qantas passengers were taken to a hospital in Perth after their plane nosedived twice while flying near the area. The Australian Transport Safety Bureau (ATSB) has not ruled out possible electro-magnetic interference from the very low frequency transmitter.



There are also plans to build an antenna array similar to the notorious HAARP project, somewhere in Western Australia. The High Frequency Active Auroral Research Program is something I've been researching since I first got on the internet back in 1994.

HAARP has the capability to "bend" the ionosphere, creating almost a reflective area that it can use to beam energy back down to the earth. The powerful HF transmitter system is able to produce approximately 3.6 million Watts of radio frequency power.

The project is funded by the Office of Naval Research and jointly managed by the ONR and Air Force Research Laboratory, with the principal involvement of the University of Alaska.

HAARP is situated north of Gakona, Alaska, near the Wrangell-Saint Elias National Park.

SECRET SOCIETIES



Yale University is home to the notorious Skull and Bones society.

Fifteen juniors are tapped each year. Around 2,500 Yale graduates have been members, mostly white males from wealthy Northeastern families: Bush, Bundy, Cheney, Dodge, Ford, Goodyear, Harriman, Heinz, Kellogg, Phelps, Pillsbury, Rockefeller, Taft, Vanderbilt, Weyerhaeuser and Whitney are some of the names on its roster. Minorities were brought into membership in the 1950s, and the first women were admitted in 1991.

The Order of Skull and Bones is a secret society begun at Yale by William Huntington Russell. His cousin Samuel Russell's family enterprise was the largest American opium smuggler. When Russell & Co. worked with the world's largest smuggler, the Scottish firm Jardine-Matheson, they were known as the Combination.

Many New England and Southern families in the "China Trade" sent their sons to Yale, and many were tapped into Skull and Bones. From Yale, Bonesmen went into and were very influential in the worlds of commerce, communications, diplomacy, education, intelligence, finance, law and politics.

PBK (PHI BETA KAPPA)

The Yale University's elite fraternity house Phi Beta Kappa, whose members include Bush, Clinton, Rockefeller, Roosevelt, Truman, Carter, Kissinger, Casper Weinberger, Robert Zoellick (head of the World Bank), Francis Ford Coppola (World Trade Centre), Dick Cheney, Condoleezza Rice, Michael Creighton (Jurassic Park) and 80's Electronic Pop artist Laurie Anderson seem to have a reverence for the Amazon Queen, Semiramis.

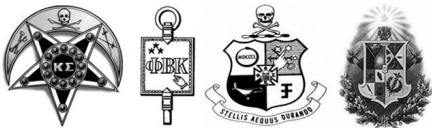
The online merchant giant Amazon.com was created by Phi Beta Kappa member Jeff Bezos in 1994 in Washington.

Amazon has its offices in the Columbia Centre, formerly the Bank of America. The top two floors are occupied by the private Columbia Tower Club.

The 80's Video game "Amazon" was also created by a fellow PBK member.

Interestingly, in Laurie Anderson's hit 80's song "Oh Superman" – she says "Here come the planes, they're American planes" almost as a pre-warning to 9/11.

Here are a few of the many fraternity logos and symbols including the PBK key, showing a finger pointing to three stars (tri-star). These symbols feature heavily in all the businesses and corporations controlled by secret societies.



Other societies and secret groups include Majesty Twelve, Order of the Quest, The Bilderberg Group, The Trilateral Commission, The Executive Committee of The Council on Foreign Relations, The PI-40 Committee, The Jason Group, The Club of Rome, The Group, The Royal Institute of International Affairs, The Tavistock Institute of Human Relations, The Round Table, The Committee of 300, The Anti Defamation League (ADL), The Aspen Institute, The American Civil Liberties Union, The British Royal Society, The Fabian Society, The Thule Society, The Union of Concerned Scientists, The International Red Cross, Kissinger Associates, The Brookings Institute, The Hudson Institute, The Ford Foundation, The Rockefeller and Carnegie Foundations, Order of St John of Jerusalem, The Russell Sage Foundation, The Milner Group, Council of 13, The Open Friendly Secret Society, The Rosicrucian's, The Brotherhood of the Dragon (or Snake), The Russell Trust, The Black Nobility families of Europe, Order of Skull & Bones, The Scroll & Key Society, The Knights of Malta, the Illuminati arm of The Freemasons, The Scottish Rites of Freemasons, and many, many more.

THE TRI-LATERAL COMMISSION

This organisation was founded in June 1973 by David Rockefeller and Zbigniew, and it's aim is to consolidate the elite heads of industry in Trilateral Nations such as the US, Japan and Western Europe, thus creating a "New World Order" that has become such a catch phrase since George Bush Senior spoke publicly about "the very real possibility" of it. Since then it has gradually gained momentum and is probably the single most recognized phrase which is used to describe the movement toward a totalitarian, fascist global government.

THE BOHEMIAN CLUB



The Bohemian Grove is a 2,700-acre virgin redwood grove in Northern California, 75 miles north of San Francisco where the world's leaders and heads of banks and corporations meet.

It's owned by the Bohemian Club, which was founded in San Francisco in 1872.

The majority of activities take place in the 109-acre main grove, in about 120 separate rustic camps nestled under the biggest, most ancient redwoods on the property.

Herbert Hoover, an enthusiastic Grover, called it "the greatest men's party on earth." Aside from the prostitutes who are rumored to be visited by Grovers at local bars and motels, it's a guys-only affair, and, historically, there's always been talk of homosexuality in the shadows under the redwoods.

The Cremation of Care ritual as previously discussed is essentially the worship of Moloch.

The only real difference being that the Bohemian Grove statue is an Owl, rather than a bull, which in Japan and Aztec Mayan cultures is the symbol of death. The Owl is also a Night Stalker and a Bird of Prey.

The owl motif can be seen hidden on the one-dollar bill, and as the logo for the National Press Club in Washington.



Richard Nixon, whose 1967 lakeside talk kicked off his successful run for the presidency, was caught on one of his Oval Office tapes describing the Grove as "the most faggy goddamned thing you could ever imagine." I called the Bohemian Club and was advised that membership requires nomination by two current members who have known you for at least two years.

THE BILDERBERG GROUP



The Hotel De Bilderberg

The Bilderbergs are a secretive organisation which began at the Hotel de Bilderberg in Oosterbeek. They represent the leaders of high finance in Western Europe, the US and Canada.

The original Bilderberg conference was held at the Hotel from May 29 to May 31, 1954. Their main objective is to create a world government and a global army through the UN. Some call them the invisible world government.

The Bilderberg meetings are highly secret, and are held at random times each year, and rarely at the same location, for security reasons.

The responsibility for security for these meetings is in the hands of the government of the country in which the meetings are held. They must supply military security, secret service, national and local police, and private security personnel to protect the privacy and safety of these very powerful international elite members who are not required to conform to regulations that private citizens are subject-to, such as customs searches, visa requirements, or public notice of their meetings.

When they meet, no "outsiders" are allowed in or near the building. They bring their own cooks, waiters, telephone operators, housekeepers, and bodyguards.

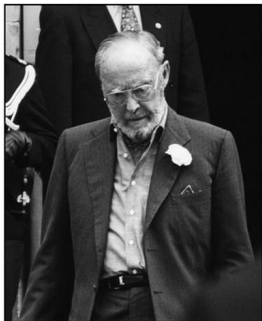
Prince Bernhard of the Netherlands and Queen Beatrix were two of the founding members and continue to attend the annual meetings.

THE HOUSE OF ORANGE

Wilhelmine of Prussia, born Princess of Prussia was the first wife of King William I of the Netherlands and so became the first Queen of the Netherlands.

Scandal rocked the Royal Family in 1976 when it was revealed that Prince Bernhard had accepted a US\$1.1 million bribe from U.S. aircraft manufacturer Lockheed Martin Corporation to influence the Dutch government's purchase of fighter aircraft.

He had served on more than 300 corporate boards or committees worldwide and had been praised in the Netherlands for his efforts to promote the economic well-being of the country. Prime Minister of the Netherlands Joop den Uyl ordered an inquiry into the Lockheed affair, while Prince Bernhard refused to answer reporters' questions, stating: "I am above such things".

The German-born prince helped found the UN front organisation the World Wildlife Fund (later renamed World Wide Fund for Nature), becoming its first president in 1961.

He also established the 1001 Club, a nature trust in 1970 to fund the organization.

He helped create Rotary International and was one of the founders of the infamous Bilderberg Group, which meets yearly in order to discuss the future of the world and issues concerning Europe as it relates to corporate globalization.

THE HAGUE



The Hague is located in the west of the country, in the province of South Holland, of which it is also the provincial capital. The Hague is the de facto seat of government, but not the capital of the Netherlands, a role set aside by the Dutch constitution for Amsterdam.

It is the home of the Senate and the House of Representatives, respectively the upper and lower houses. These together form the States-General. Queen Beatrix of the Netherlands lives and works in The Hague. All foreign embassies and government ministries are located in the city, as well as the Hoge Raad der Nederlanden (Supreme Court), the Raad van State (Council of State).

Beatrix (Beatrix Wilhelmina Armgard; born 31 January 1938) has been the Queen regnant of the Kingdom of the Netherlands since 30 April 1980, when her mother, Queen Juliana, abdicated.

Queen Beatrix is a member of the Bilderberg Group. This has led to controversy since the Queen of The Netherlands has to be accountable to parliament. So far this has not been possible concerning her yearly attendance to the Bilderberg Group. Beatrix is also an honorary member of the Club of Rome.

The Hague is the world's 2nd UN city, after New York. In line with the city's history as an important convention center and the current presence of institutions such as the ICJ, The Hague's city council employs a city branding strategy that aims to establish The Hague as the Legal Capital of the World and the International City of Peace and Justice.

The 1001 Club is a trust that helps fund the World Wide Fund for Nature. It was established in 1970 by the then head of the WWF, Prince Bernhard of the Netherlands, with help from Anton Rupert, a South African entrepreneur. They persuaded 1001 individuals to join the club, where each member would contribute US \$10,000 to the trust. The resulting \$10 million fund helps to towards the WWF's basic costs of administration.



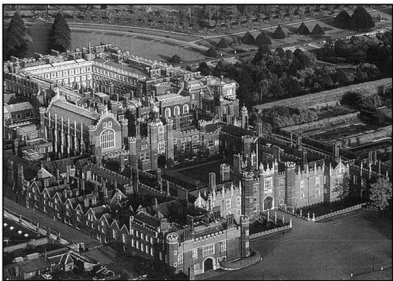
The membership of the 1001 Club largely consists of managers of banks and multinationals from around the world. Examples from past and present include Sir Eric Drake of British Petroleum, Sir Val Duncan of Rio Tinto, Harry Frederick Oppenheimer and Sidney Spiro of Anglo-American Corporation, the British and French Rothschild's, Michel David-Weill of Lazard, Laurence and David Rockefeller, Henry Ford II, Baron Hans Heinrich Thyssen-Bornemisza, Peter von Siemens, and Berthold Beitz of Krupp. Among the more remarkable members have been Salem bin Laden, Osama bin Laden's older half-brother; Mobutu Sese Seko, the dictator of Zaire; BCCI founder and president Agha Hasan Abedi; early Zionist operatives as Louis Bloomfield and Tibor Rosebaum; and the controversial businessman Nelson Bunker Hunt

HAMPTON COURT



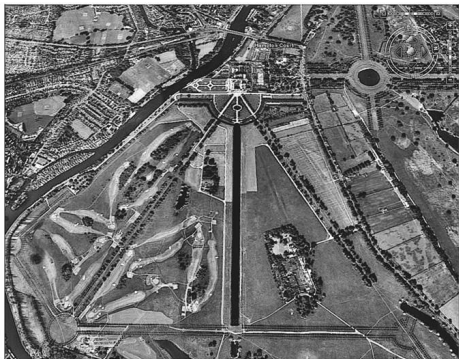
Hampton Court Palace is a Royal palace in the London Borough of Richmond upon Thames in south west London; it has not been lived in by the British Royal family since the 18th century.

It was originally built for Cardinal Wolsey, a favourite of King Henry VIII, circa 1514; in 1529, as Wolsey fell from favour, the palace was passed to the King, who enlarged it. Thomas Wolsey (c.1471 – 1530), who was born in Ipswich, Suffolk, England, was a cardinal of the Roman Catholic Church.





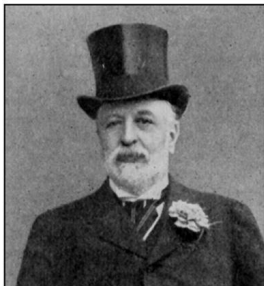

THE BANKERS

THE ROTHSCHILD FAMILY



The Rothschild's were supporters of the State of Israel, and Baron Edmond James de Rothschild was a patron of the first settlement in Palestine at Rishon-LeZion. In 1917 Walter Rothschild, 2nd Baron Rothschild was the addressee of the Balfour Declaration, which committed the British government to the establishment in Palestine of a national home for the Jewish people.

James A. de Rothschild financed the Knesset building as a gift to the State of Israel.

The Supreme Court of Israel building was donated to Israel by Dorothy de Rothschild. Outside the President's Chamber is displayed the letter Ms. Rothschild wrote to Prime Minister Shimon Peres expressing her intention to donate a new building for the Supreme Court.

The family's rise to international prominence began with Mayer Amschel Rothschild (1744–1812), the son of Amschel Moses Rothschild, a moneychanger. Born in the ghetto (called "Judengasse" or Jew Alley) of Frankfurt am Main, he developed a finance house and spread his empire by installing each of his five sons in European cities to conduct business. An essential part of Mayer Rothschild's strategy for future success was to keep control of their businesses in family hands, allowing them to maintain full discretion about the size of their wealth and their business achievements. Mayer Rothschild successfully kept the fortune in the family with carefully arranged marriages between closely related family members. His son Nathan Mayer Rothschild was instrumental in the financing of the British war effort, handling the shipment of bullion to the Duke of Wellington's army in Portugal and Spain, as well as arranging the payment of British financial subsidies to their Continental allies. Through the commissions earned on these transactions, the Rothschild fortune grew enormously.

The four brothers helped co-ordinate activities across the continent, and the family developed a network of agents, shippers and couriers to transport gold and information across Europe. This private intelligence service enabled Nathan to receive in London the news of Wellington's victory at the Battle of Waterloo a full day ahead of the government's official messengers. Therefore, Nathan would have known it was safe to invest heavily in the London economy a full day before most businessmen.

N M Rothschild & Sons does most of its business as a mergers and acquisitions advisor. In 2006, it ranked second in UK M&A with deals totalling \$104.9 billion. In 2006, it recorded a pre-tax profit of £83.2 million with total assets of £5.5 billion.

WARBURG



Paul Moritz Warburg (August 10, 1868 — January 24, 1932) was a Jewish-German-American banker and early advocate of the U.S Federal Reserve system.

Warburg was born in Hamburg, Germany, to a successful Jewish banking family. His parents were Moritz and Charlotte (Esther) Warburg. After graduating he entered the employment of Simon Hauer, a Hamburg importer and exporter, to learn the fundamentals of business practice. He similarly worked for Samuel Montague & Company, bankers, in London in 1889-90, the Banque Russe pour le Commerce Etranger in Paris in 1890-91.

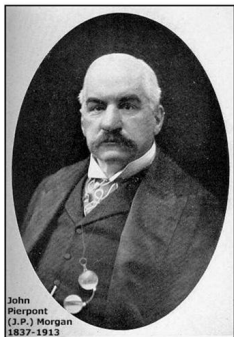
The Warburg's took their surname from the city of Warburg.

The brothers Moses Marcus Warburg (1763 - 1830) and Gerson Warburg (1765 - 1826) founded the M.M.Warburg & CO banking company in 1798 that is still in existence. Moses Warburg's great-great grandson, Siegmund George Warburg, founded investment bank S. G. Warburg & Co in London in 1946. Siegmund's second cousin, Eric Warburg, founded Warburg Pincus in New York in 1938. Eric Warburg's son Max Warburg (not to be confused with Eric's father Max Warburg) is currently one of the three partners of M.M.Warburg & CO.

At the time of his death he was chairman of the Manhattan Company and a director of the Bank of Manhattan Trust Company, Farmers Loan and Trust Company of New York, First National Bank of Boston, Baltimore & Ohio Railroad, Union Pacific Railroad, Los Angeles & Salt Lake Railroad, Western Union Telegraph Company, American I.G. Chemical Company, Agfa Anso Corporation, and Warburg & Company of Amsterdam.

He became a director of the Council on Foreign Relations at its founding in 1921, remaining on the board until his death

JP MORGAN



John Pierpont Morgan (April 17, 1837 – March 31, 1913) was an American financier and banker who dominated corporate finance and industrial consolidation during his time.

In 1892 Morgan arranged the merger of Edison General Electric and Thompson-Houston Electric Company to form General Electric.

After financing the creation of the Federal Steel Company he merged the Carnegie Steel Company and several other businesses to form the United States Steel Corporation in 1901.



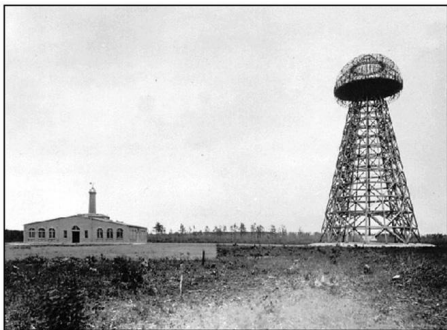
Not surprisingly the JP Morgan Memorial has the appearance of a Templar Tomb and includes an Egyptian Obelisk.

In 1900, Morgan financed inventor Nikola Tesla and his Wardenclyffe Tower with \$150,000 for experiments in radio. However, in 1903, when the tower structure was near completion, it was still not yet functional due to last-minute design changes that introduced an unintentional defect. Morgan didn't like the idea because there was no-where to put the meter.

Tesla's vision of free power didn't agree with Morgan's worldview, nor would it pay for the maintenance of the transmission system. Construction costs eventually exceeded the money provided by Morgan, and additional financiers were reluctant to come forth. By July 1904, Morgan and the other investors finally decided they would not provide any additional financing. Morgan also advised other investors to avoid the project.

Wardenclyffe Tower, also known as the Tesla Tower, was an early wireless telecommunications tower designed by Nikola Tesla and intended for commercial trans-Atlantic wireless telephony, broadcasting, and to demonstrate the transmission of power without interconnecting wires.

The tower was named after James S. Warden, a western lawyer and banker who had purchased land in Shoreham, Long Island, about sixty miles from Manhattan.



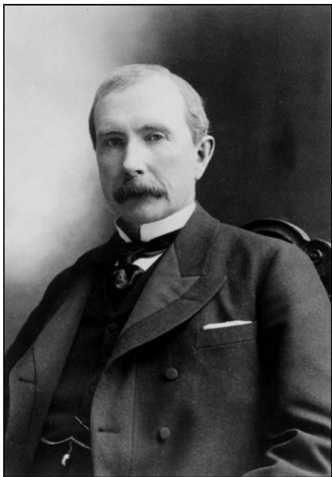
The Wardenclyffe tower under construction.

Here he built a resort community known as Wardenclyffe-On-Sound. Warden believed that with the implementation of Tesla's "world system", a "Radio City" would arise in the area, and he offered Tesla 200 acres (81 hectares) of land close to a railway line on which to build his wireless telecommunications tower and laboratory facility.

ROCKEFELLER



John D. Rockefeller

John Davison Rockefeller (July 8, 1839 – May 23, 1937) was an American industrialist and philanthropist. Rockefeller revolutionized the petroleum industry and defined the structure of modern philanthropy.

In 1870, he founded the Standard Oil Company and ran it until he officially retired in 1897. Standard Oil began as an Ohio partnership formed by John D. Rockefeller, his brother William Rockefeller, Henry Flagler, chemist Samuel Andrews, and a silent partner Stephen V. Harkness. Rockefeller kept his stock and as gasoline grew in importance, his wealth soared and he became the world's richest man and first American billionaire, and is often regarded as the richest person in history.

THE FEDERAL RESERVE

In 1910, on Jekyll Island, seven of the worlds most powerful men, representing the above bankers and approximately one quarter of the world's wealth got together on Jekyll Island to create the Federal Reserve System, a privately controlled banking cartel to control the US economy which has controlled the currency ever since.

Those men were Senator Nelson Aldridge, a Republican, Paul Warburg (Kuhn Loeb/Rothschild and Credit Suisse), Abraham Andrew (Assistant Secretary of the Treasury), Frank Vanderlip (President of the National Bank of New York), Henry Davison (JP Morgan representative), Charles Norton (President of the 1st National Bank) and Benjamin Strong (also representing JP Morgan).

The private Federal Reserve System, which issues fiat U.S. Federal Reserve Notes, is financially owned and controlled by the Crown from Switzerland, the home and legal origin for the charters of the United Nations, the International Monetary Fund, the World Trade Organization, and most importantly, the Bank of International Settlements.

THE GEORGIA GUIDESTONES



The Georgia Guidestones are a controversial granite monument in Elbert County, Georgia, USA which is associated with the Illuminati's plans to supposedly reduce the world's population by 80%. A message comprising ten guides is inscribed on the structure in eight modern languages, and a shorter message is inscribed at the top of the structure in four ancient languages: Babylonian, Classical Greek, Sanskrit, and Egyptian hieroglyphs.

The monument is almost twenty feet (6m) tall, and made from six granite slabs weighing more than 240,000 pounds in all. One slab stands in the center, with four arranged around it.

A capstone lies on top of the five slabs, which are astronomically aligned. An additional stone tablet, which is set in the ground a short distance to the west of the structure, provides some notes on the history and purpose of the Guidestones.

Recently, the stones were defaced as word began to spread about their existence, and what they could possibly stand for. They have been there since June 1979, when a person under the pseudonym R. C. Christian hired Elberton Granite Finishing Company to build the structure.

The explanatory tablet near the monument reads: "Let these be guidestones to an age of reason."

The logo was designed by Wolff Olins, a brand consultancy based in London and New York. They have been responsible for the brand design work behind GE Capital, Sony Ericsson, Unilever and RED.

The company was founded in Camden Town, London, in 1965 by designer Michael Wolff and advertising executive Wally Olins. Wolff left the business in 1983, and Olins in 2001, though both are still active in the field of branding.

From 1965 to the early 1990s, Wolff Olins played a central part in developing the craft of corporate identity in Europe and working with over 500 organizations worldwide. Among his clients were Audi, Apple records, P&O, Renault, Pilkington and Volkswagen. The current designs for Shell and BP are also some of Wolff Olins work.

They appear to be literally building a new Zion.

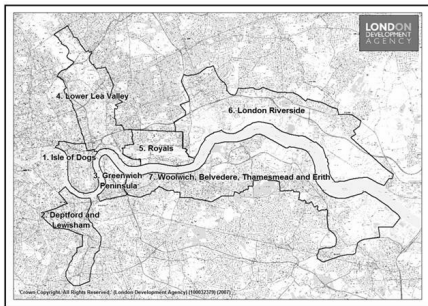
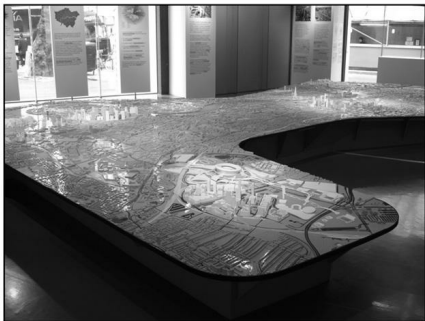
I stumbled across this when I decided to check the internet to see if there was any projects to be completed by 2012 that mention 144,000.

"If these plans succeed, this new housing will be an investment that will certainly benefit the region years after the games have ended."

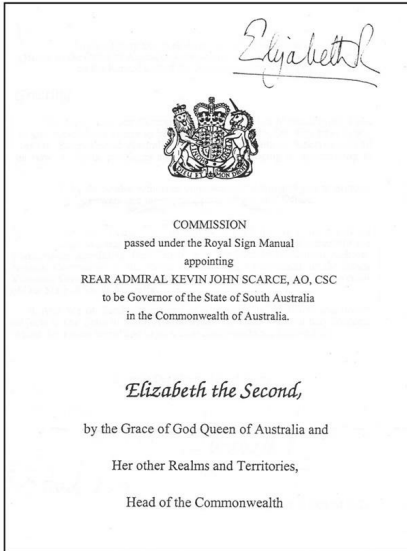
The £80m regeneration project will provide a range of town centre uses including (you guessed it) 144,000 sq ft of new retail. There was even a model and a map.
